7. New applications to vote by proxy must be received by the Electoral Registration Officer by 5pm on Wednesday, 24 April 2019
8. The deadline for new applications to be received by the Electoral Registration Officer to vote by proxy on grounds of occupation, service or employment or a medical condition, illness or disability arising after 5pm on Wednesday, 24 April 2019 is not later than 5pm on Thursday, 2 May 2019.
