

**MINUTES OF THE ANNUAL MEETING OF THE  
FULFORD PARISH COUNCIL  
HELD ON THURSDAY, 15<sup>TH</sup> MAY 2008 AT 8.00 P.M.  
AT FULFORD VILLAGE HALL**

**29/08 ELECTION OF CHAIRMAN**

One nomination having been received, it was

**RESOLVED** – That Councillor Mrs. Brayford be elected Chairman of the Parish Council for the ensuing year.

Councillor Mrs. Brayford thanked the Members for the honour conferred upon her and afterwards the statutory Declaration of Acceptance of Office was signed. Members then expressed their appreciation of the work undertaken by the previous Chairman, Councillor Shaw, in his 12 month period of office.

**30/08 ELECTION OF VICE-CHAIRMAN**

After some discussion and then one formal nomination being received, it was

**RESOLVED** – That Councillor Mrs. Bennett be elected Vice-Chairman of the Parish Council for the ensuing year.

The statutory Declaration of Acceptance of Office was signed.

**31/08 MINUTES**

**RESOLVED** -That the Minutes of the meeting of the Council held on 10<sup>th</sup> April 2008, having been circulated, be confirmed as a correct record and signed by the Chairman.

**32/08 MATTERS RAISED BY THE PUBLIC AT THE ANNUAL PARISH MEETING**

The members of the public who attended the Annual Parish Meeting held earlier in the evening had again reiterated their concerns with regard to anti-social behaviour in the Adamthwaite Drive area of Blythe Bridge. Letters from the Police and the Staffordshire Youth Service were submitted.

Despite earlier optimism, the problem was getting no better and although the Police were praised for their support, the major concern was the lack of supervision to the young people resident in Mangrove House by its Supervisors. It appeared that with the reorganisation of the Youth Service within the County, no organisation could be identified as being responsible for the licensing/control of the premises themselves. The Clerk was asked to write to appropriate bodies, the Police and the MP seeking action to bring about badly needed support for the residents of the area.

### 33/08 COUNTY & BOROUGH COUNCILLORS' REPORTS

County Councillor Parry reported that the Stallington Speedwatch Scheme was now operational. He was still pursuing the execution of the highway improvement works to Stallington Village following the redevelopment of the hospital site but there were still legal problems to overcome.

Borough Councillor Harp reported that despite his concerns, the change of use planning applications in respect of the Creda site had been permitted but JCB were still negotiating for the acquisition of the site. At The Wood, Stallington Road, Meir Heath building works had commenced despite the Enforcement Notice and the Borough Council were pursuing the matter. The Borough Council had recently met to try and resolve the illegal occupation of the Spot Acre gypsy site and it was hoped that a speedy solution could be found. The present position with regard to the Untidy Site Notice at 54 Birkholme Drive, Meir Heath was explained and the Clerk was asked to write formally to the Borough Council seeking an early redress to the problems experienced by neighbours which were first raised some 30 years ago.

### 34/08 FINANCE
