91/11 COUNTY, BOROUGH COUNCILLORS' & POLICE REPORTS

The Borough Councillors reported that despite putting forward objections backed by a petition from local residents the Borough Council's Planning Committee had approved the development at 25 Hilderstone Road.

Work is currently underway on the Creda site following Panel Co decision to relocate a large part of its operation to this site. It is expected to create about 400 jobs, with 30 by the end of November.

Details of a response from the Borough Council's Senior Conservation Officer regarding Stallington Hall were given to the meeting.

Police report – enough volunteers had now come forward to enable a new speed watch scheme to be started on Stallington Lane. Speed checks are being carried out across the parish. Parking outside schools is being tackled with the start of a 'ziggy-zaggy' scheme at Fulford school.
