- the loss of privacy of neighbouring properties and the Council also believes this property has already been considerably enlarged in the past and that the planned work will possibly take the size of the property beyond the permitted 70%.

13/19004/FUL – land adjacent 9 Field Close, Blythe Bridge, Stoke-on-Trent for the following reasons:

- impact on the surrounding area and in particular the new dwellings would not be in keeping with neighbouring properties (there are no other 3 storey properties in the area);
- loss/damage to trees;
- access is very difficult up a very narrow lane running off a cul-de-sac with the extra traffic having an adverse effect on neighbouring properties and:
- loss of privacy to neighbouring properties.
